**AMENDMENT TO DECLARATION OF CONDOMINIUM**

THIS AMENDMENT TO DECLARATION OF CONDOMINIUM (the "Amendment") is made by RESIDENCES AT VILLA MEDICI CONDOMINIUM ASSOCIATION, INC., a not-for-profit Florida corporation formerly known as RESIDENCES AT MILLENIA CONDOMINIUM ASSOCIATION, INC., a not-for-profit Florida corporation (the "Condominium Association").

**WITNESSETH:**

WHEREAS, RESIDENCES AT MILLENIA, a Condominium (the "Condominium") was created by the recordation of the Declaration of Condominium (the "Declaration") for the Condominium on February 27, 2006 in Official Records Book 8499, at Page 4131, of the Public Records of Orange County, Florida; and

WHEREAS, the Condominium Association wishes to amend the Declaration in accordance with the provisions of Article VIII of the Declaration;

NOW, THEREFORE, the Condominium Association hereby amends the Declaration to as follows:

- The name of the Condominium is hereby amended to be:

- Wherever the name of the Condominium Association appears in the Declaration and/or within the exhibits attached to the Declaration, the name of the Condominium Association is hereby amended to be:  
RESIDENCES AT VILLA MEDICI CONDOMINIUM ASSOCIATION, INC., a not-for-profit Florida corporation
- Except as the Declaration is amended as provided herein, each and every one of the terms and provisions of the Declaration shall remain unmodified and shall continue in full force and effect.

IN WITNESS WHEREOF, the Condominium Association has executed this Amendment to Declaration of Condominium this \_\_\_ day of December, 2006.

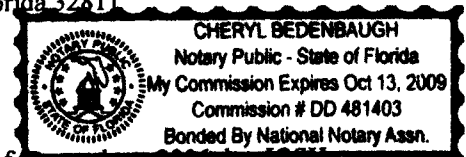
